  - Cassandra Arnell
    - Thank James Hanzelka for all his work as the Interim GM. The Chartway Impact fees account is closed, and the Recreation bank account.
    - Pageant Day issue:
      - excluding the youth not attending Stansbury High School, even though they live in Stansbury Park. Ammon Jacobsmeyer will talk to Rachel Torzillo and Sieta Jacobsmeyer about the issue of excluding Stansbury youth. James Hanzelka mentioned that the Pageant next year will not be integrated within Stansbury Days.
      - James Hanzelkawants to know if we could make a post on social media to include all Stansbury Park youth in the pageant.
      - Ammon Jacobsmeyer feels that Stansbury Service funds going to an employee's child is not right. Cassandra Arnell does not quite agree with that because the judges are not associated with the agency.
      - John Wright feels that we should learn as we go.
