2. 2023.09.02 D

- a. Presentation and Discussion of 2024 tax rate Information to Greenbelt Service District and Recreation Service District.
- b. Presentation made by James Hanzelka. The current tax rate is .000685. Less than half of what was deemed needed to operate.
- c. Our current rate is about 1.5 million short of operation cost to maintain the parks and facilities.
- d. James presents all the maintenance issues around Stansbury Park that need to be fixed all add up to about 1.2 million dollars.
- e. Tax rate history. 2013 .00014. 2019 did a rate increase to .001054. Since 2019 the tax rate has dropped for citizens because the amount that agency has received has stayed bottom out.
- f. Tax Rate schedule will be as follows.
 - i. 10/3 Public Meeting for Board to agree on Rate.
 - ii. Parcel and Newspaper sent Oct 11th.
 - iii. Open House 18-24th. Truth in taxation on 24th.
 - iv. Final vote on 25th of October.
- g. Parcel specific notice tells the individual parcel rate.
- h. Currently the agency is 300.000.00 over budget in 9 months and that will continue to happen if the same tax rate is kept.



- i. Golf and Parks and Rec cannot get any new equipment at the current tax rate.
- j. Both golf and parks need a mechanic each and assistant mechanics.
- k. At the current rate there is no money. .001285 we can sustain but not improve. .0014 we can begin to build back contingency funds and begin to make repairs.
